Annual Percentage Rate (APR) for Purchases & Balance Transfers	2.99%, 3.99%, 4.99%, 5.99%, or 7.99% Introductory APR for the first 6 months from account opening, depending on your credit history. After that, your Standard APR will be 13.40%, 14.40%, 15.40%, 17.40%, or 17.99% depending on your credit history. This APR will vary with the market based on the Prime Rate.
