

# **THE WAUNA CREDIT UNION ESTATEMENT GIVEAWAY PROMOTION**

## **OFFICIAL RULES**

**NO TRANSACTION NECESSARY TO ENTER OR WIN.**

**A TRANSACTION WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. PROMOTION PERIOD:** The Wauna Credit Union eStatement Giveaway Promotion (the “Promotion”) begins on January 5, 2026, and ends on March 31, 2026 (“Promotion Period”). Drawings will be conducted between April 1, 2026, and April 10, 2026.

**2. ELIGIBILITY:** This Promotion is open to all Wauna Credit Union members, 18 years of age or older, who enter as described below. The following individuals are not eligible to win: officers, directors, independent contractors, volunteers, and employees of Wauna Credit Union (“Sponsor”), as well as their immediate family members (spouse, parent, child, sibling, in-laws) and members of the same household. Winning a prize is contingent upon fulfilling all requirements set forth in these Official Rules.

**3. PRIZES:** A total of seven (7) prizes will be awarded. Each prize consists of a gift certificate or voucher (at a value of up to \$500) to one of 21 local businesses pre-selected by Wauna Credit Union staff. Drawings will be conducted between April 1, 2026, and April 10, 2026. Prizes are non-transferable and cannot be exchanged. There is no cash value.

**4. HOW TO ENTER:** To enter the Promotion during the Promotion Period:

- a. Have or enroll for electronic delivery of Wauna Credit Union account statements. No purchase necessary to enter. Account information and enrollment in eStatements will be verified by Wauna Credit Union staff.
- b. Provide name, address, and phone number on a 3x5 card and mail it to: Wauna Credit Union, 101 Truehaak, PO Box 67, Clatskanie, OR 97016. Must be postmarked prior to the end of the Promotion Period.

A maximum of one (1) total entry per member is allowed. Members who wish to enter in-branch may request assistance from Wauna Credit Union staff to complete the eStatement registration process.

**5. WINNER SELECTION AND ODDS:** Eligible entries will be included in random drawings beginning April 1, 2026, and completed by April 10, 2026. One winner will be selected for each WCU branch for a total of seven (7) winners. Member must be in good standing at time of drawing and prize notification. Each winner is responsible for all applicable federal, state and

local taxes. Odds of winning depend on the number of eligible entries received. A maximum of one (1) entry per person may be submitted.

**6. WINNER NOTIFICATION:** Potential winners will be notified by phone and/or email within five (5) business days following the drawing. Winners must comply with all terms of these Official Rules to be confirmed as an official winner. Each potential winner may be required to complete and return a Declaration of Eligibility/Compliance (including providing their Social Security Number for tax purposes) and a Media Release, as permitted by law, within ten (10) calendar days of notification. Failure to do so will result in forfeiture of the prize, and an alternate winner may be selected.

All decisions regarding the selection and verification of winners are final and binding.

**7. GENERAL CONDITIONS:** By entering this Promotion or accepting a prize, entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which shall be final in all matters. By accepting a prize, winners grant Sponsor the right to use their name, likeness, and photograph for advertising and promotional purposes without additional compensation, unless prohibited by law.

All federal, state, and local laws and regulations apply. Sponsor reserves the right to cancel, modify, or suspend the Promotion if any fraud, technical failure, or other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Promotion. Sponsor may disqualify any individual found to be tampering with the entry process or acting in violation of these Official Rules.

No more than the stated number of prizes will be awarded.

By entering this promotion, each entrant releases Sponsor and its respective directors, officers, employees, agents, and subsidiaries from any and all liability, claims, causes of action, suits, and demands arising from or in connection with its lawful actions in conducting the Promotion.
