MICHAEL HOAG

SCAPPOOSE, OR

A Scappoose native, Michael attended Oregon College of Education (WOU) and University of Oregon School of Dentistry (OHSU), graduating in 1976. He practiced general dentistry from 1976 until 1988, before joining OHSU School of Dentistry from 1990-2010. While at OHSU, he worked in several different departments as an instructor and an assistant professor. For the Scappoose School District he has held various coach and assistant coach positions over the years in football, basketball, baseball, and softball, and is currently an assistant softball coach. He has held leadership positions with several organizations including the Scappoose Booster Club, a board position for Oregon Dental Service (Moda Health) from 1977-1980, and the Scappoose Alumni Association from 2000-2010. He has volunteered as a softball coach, baseball coach, umpire, and officer for Scappoose Little League for many years and he held a board position for 6 years in the Portland Softball Umpire's Association, officiating in two State 6A Softball Championship games (2011 & 2018) and being honored as the State of Oregon Softball Umpire of the Year in 2018. Mike has served on WCU's Supervisory Committee from 2016 to 2020 and has been the on the board for the past 3 years. He continues to be active in his community through working with youth and alumni associations as he is committed to giving back.
